Unfinished Business: Update from water initiative:

-It was determined, the designing a water system that supplies as many residents as possible is the most cost efficient, timely and equitable method of supporting the resident's needs.

- Looking at getting water from Monroe.

-Funding options were discussed there were alternatives from both the USDA and DWRF. With 20- and 40-year loans available. Interest rates are being monitored continually.

New Business:

1. Milan Area Fire Dept. London Township is now using GIS maps on all parcels. Which is the most accurate way of determining the correct cost to the Milan Area Fire Dept. Last year it was 16.38%, this year it is 14.36%.

Motion by Supervisor Taepke, seconded by Treasurer Beauchamp to approve the Milan Fire Departments Budget Fiscal year 2019-2020 of \$413,600, as well as the Fiscal Year 2019-2020 capital outlay, totaling \$513,600. London Township portion will be 14.36%.

2. Monroe County Health Dept. tests our water monthly and the entire system is inspected once every five years. The most recent inspection determined that the water was becoming stagnant within the two tanks, because the Township Hall does not use enough volume. It was recommended to disconnect one tank, and clean and sterilize the tank the Township Hall will continue using. Casing on deep well is damaged. Monroe County Health Department said the Township Hall's well needs to be properly capped and abandoned so it does not affect surrounding wells.

Trustee Turner asked to get quotes.

3. Zoning Administrator would like to attend a training session in Frankenmuth Aug. 20 cost \$166.
