1. Building Keys:

-Trustee Pinkowski and Trustee Nichols agreed the Township Hall should be rekeyed as new administration comes in for the back and front door. This was just done a few months ago and there are now cameras. Clerk Sharp will investigate the price.

Motion made by Trustee Pinkowski seconded by Clerk Sharp to table rekeying of the outer doors to the Township Hall to get prices.

2. Milan Area Fire Department (MAFD)

-Supervisor Turner and Trustee Pinkowski attended the MAFD meeting on a new Fire Station for the MAFD. London Township uses 14.11% of the MAFD particularities. Supervisor Turner will get the numbers on what this will cost the Township.

3. Building Department:

-The Building Dept. has sent in complaints to the State of Michigan and to the Monroe County Heath Dept. about employees not using masks, this was proven to be unfounded. -Complaints have come in that the Building Dept. is not issuing permits. Recently someone buying a home has not been able to obtain permits to fix it to sell it as it is not their primary residence. Supervisor Turner has talked with the State Building Dept. and our Attorney. They have stated this is not factual. Our Building Inspector stated he will not issue these permits. There now must be a hearing and appoint a 5-member board.

Motion made by Treasurer Moore, seconded by Trustee Nichols to terminate CES Contract utilizing the 90-day clause in their contract so we have time to get bids/hire a replacement Building Official.

- -Amanda Taepke stated the 2 Mils for the MAFD may help cover some of the MAFD new hall. Has not seen the minutes on Facebook and Londontwp.org site, Deputy Straub will investigate this. noted there were errors on the December 2020 Minutes the misspelling First Merchants Bank and the misspellings of Nichols a couple times. Had question on inspections. Thanked Trustee Nichols, Clerk Sharp and Supervisor Turner for looking out for the residents.

Board of Trustee Comments:

- -Clerk Sharp also reminded anyone interested in being an alternative delegate to the Raisin River Watershed Council to let her know.
- -Trustee Nichols ran on seeking out funding for Township Wide Internet, He is reaching out to County Commissioners for help. Washtenaw County has started a task force at the County Commissioners level he found out about the Rural Digital Opportunity Fund a Federal Broadband Grant that offers \$9.2 Billion in funding to bring digital connectivity to more than 10 million Americans. In Michigan 13 internet providers may receive \$362 million over 10 years to 249,000 locations. Would like to see Monroe County do this. Supervisor Turner is talking with Senator Peters on the internet issue also.
